1. Tender document fee - Rs. 3,000/- + GST @18%
2. Works comprise of – Demolition of existing restrooms (2 units) and reconstruction.
3. Minimum eligibility that the bidder should demonstrate –
 - 3.1 The Contractor should have an experience in similar work civil construction and interior works including ACP, glass work, flooring, MS Fabrication, Erection and Commissioning etc for at least last 7 years i.e. from 1.4.2020 to 31.3.2026 with good quality wood work with Molding, carving, detailing, external claddings, PU painting & polish work etc.
 - a. Similar work means - RCC framed structure buildings like residential / institutional / industrial / commercial buildings etc. but not industrial sheds or prefab units etc.
 - b. Preference shall be given for above works completed in local region.
 - c. Work orders + completion certificates with details of punctual execution + client contact details to be submitted.
 - 3.2 The Contractor should have completed relevant civil and interior work, MS Pipe Fabrication/ Erection/ Commissioning for at least 3 sites of area of 8000 -10000 sqft for a value of minimum Rupees of 1 crore project during 3 years i.e. from 1st April 2023 to 31st March 2026 (certificate/proof required).
 - 3.3 The Contractor should be accustomed of working at Indore or surrounding region for Interior and construction work, list require for project done with photographs.
 - 3.4 Average annual receipt from business of construction in last 3 FY years should be more than 1 Cr.
 - 3.5 Should be a profitable entity in at least 2 of last 3 years.
 - 3.6 No history of abandoned / terminated projects, major litigation / arbitration (in last 5 years).
 - 3.7 Key personnel for project : In-house or tied-up qualified civil engineer graduate with 5+ years experience and a site supervisor with experience of 3+ years.
 - 3.8 Statutory registrations like GST, PAN, Labour License, EPF & ESIC registration etc.
