REPORT

It was my pleasure to conduct elections to the Office Bearers, Members of the committee and Members of Cricket committee of Madhya Pradesh cricket Association. The process of conduct of election was got managed well within the time lines specified in the schedule as approved by the management.

The distribution of the nomination forms/applications to the interested candidates, collection of the completed nomination applications following the timelines and thereafter the process of scrutiny of nomination papers was smooth and systematic following the set regulations and guidelines.

After completion of the scrutiny of nomination forms, it was noticed that the number of the contesting candidates in two categories viz. "Office Bearer" and "Affiliated Institution" was more than the number of positions to be elected. However, during the time provided for withdrawal of nominations, it was seen that two candidates, one each from Office Bearer category and Affiliated Institution category withdraw their nomination applications making the number of contesting candidates in each category, equal to the number of positions to be filled by the conduct of elections.

Considering the above situation, having number of contesting candidates exactly equal to the positions to be elected by the process of election in each category, the contesting candidates were declared elected unopposed in each category.



As there was no other business to be transacted under the current assignment, the election process was declared to be complete. Chief Executive Officer of Madhya Pradesh Cricket Association, Mr Rohit Pandit provided all the required assistance for the timely and successful completion of the election process. It is necessary to mention here that the election process was overall peaceful and without any untoward incident.
